RESOLVED FURTHER THAT the RHP be signed by each of the Directors of the Company and [Abhishek Kumar Pandey], Company Secretary and Compliance Officer for and on behalf of the Company as required under applicable laws.

RESOLVED FURTHER THAT Mrs. Asha Narang, Director (Din: 00296714) Mr. Sanjeev Verma, Director (Din: 00296825) and Mr. Saksham Leekha, Managing Director (Din: 07389575) be and are hereby severally authorised to undertake necessary steps to implement the above resolution in relation to the RHP and the Issue, including but not limited to initialling and/or signing any corrections, changes, amendments etc. to the RHP as may be required, and to date and deliver the RHP for submission and/or filing on behalf of the Company with the ROC, Securities and Exchange Board of India, Stock Exchanges and such other regulatory bodies as may be required by law, along with submission of Material Contracts and Documents for Inspection listed in the RHP, and/or to withdraw the RHP, and/or to settle any questions, difficulties or doubts that may arise in this regard and to do all such acts, deeds, matters and things and execute and deliver all engagement letters, memorandum of understanding, agreements and such other documents as may be considered necessary or desirable for such purpose, including as may be directed by the said authority in accordance with the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended (to the extent applicable), Companies Act, 1956, Companies Act, 2013 and other applicable laws.

RESOLVED FURTHER THAT any amendment, supplement, corrigenda or notice to investors issued by the Exchange in relation to the RHP that may be filed with the ROC, Securities and Exchange Board of India, Stock Exchanges or any other regulatory authority be and is hereby approved in accordance with applicable
